

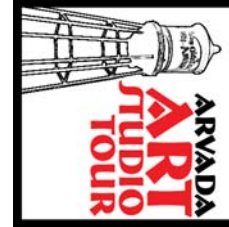
Statement of Liability:

Elegibility:

The ARVADA ART STUDIO TOUR is a juried event open to artists working in all media whose studios have an Arvada, CO address. We are looking for high quality, creative, professional work. Artists must exhibit their own work - no imports, work from kits, or manufactured products will be allowed.

Artists whose studio space is not accessible to the public or who are not comfortable hosting such an event in their homes will need to find alternative space to exhibit their work. The Arvada Art Studio Tour board will endeavor to facilitate the matching of artists with available spaces, but the ultimate responsibility for providing suitable space falls to the artist.

How to Enter:

Fill out and sign the attached form. Send in the form, a check for the entry fee, an artist resume (including exhibits, awards, education, etc.), and three images of representative work (digital images are preferred, but slides or photos will be accepted). Images should be labeled with your name, title, size, date, and medium of each work. Make checks payable to "Arvada Art Studio Tour" and mail entry package to Arvada Art Studio Tour, PO Box 2142, Arvada CO 80001-2142.

Jurors:

Judy Gardner, Fred Reim, and Sharon Meriash.

Cost:

A \$40 non-refundable application fee should be included with your application. If accepted, there will be an additional participation fee of \$110 to cover the costs of postcards, advertising and promotion of the show. For group studios, please call Judy Gardner at 303-421-9948 for an explanation of the fee structure when more than one artist is exhibiting in a single space.

Sales:

The Arvada Art Studio Tour does not charge any commission on sales.

Sales Tax:

Artists are responsible for collecting and reporting all applicable sale taxes for any sales that occur during the tour.

Judging:

The Jurors will review the images and resumes. In the event you are a finalist for the tour, a visit to your studio will be scheduled to view your work and studio space in person.

Liability:

If accepted on the tour, proof of liability insurance will be required. This can be a letter or form from your insurance company stating that they are aware of your participation in the tour and that you have liability coverage.
